





**A BILL FOR AN ACT**

To re-amend LTO:11-24 as amended by LTO:11-45 by amending section 1 and 4 thereof, to change the lapse date and for other purposes.

**BE IT ENACTED BY THE 12<sup>TH</sup> LELU TOWN COUNCIL:**

1. **SECTION 1. Appropriation.** The sum of \$10,000.00 is hereby
2. appropriated from the Lelu Town Treasury to cover all costs
3. related to the establishment of a local trading center for
4. the people of Lelu for the Fiscal Year ending September
5. 2022.
6. **SECTION 2. Apportionment:** The sum appropriated by this Act
7. shall be apportioned as follows:
  8. a. Contractual Services \$3,500.00
  9. b. Contingencies \$3,500.00
  10. c. All Others \$3,000.00
11. **SECTION 3. Management:** The sum appropriated by this Act
12. shall be managed and administered by the Mayor of Lelu
13. and shall be accounted for in accordance with the Lelu
14. Town Ordinance and applicable laws. The Mayor shall be
15. responsible for ensuring the amount appropriated is used
16. for the purpose for which appropriated and that no
17. obligations are incurred in excess for the appropriation.


