BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL

- 1. **Section 1:Purpose:** The purpose and intent of this bill is stated clearly in its title.
- 2. **Section 2:Appropriation**: The sum of \$5,000.00 is hereby appropriated from the
- 3. Lelu Town Government Saving Account for the purpose of funding public
- 4. projects and social programs for the people in Lelu.
- 5. **Section 3:Appointment**: The sum appropriated in Section 2 of this Act shall be
- 6. apportioned and disbursed as follows:
- 7. a. The Bible Purchase

5,000.00

- 8. **Section 4: Management**: The sum appropriated by this Act shall be managed
- 9. and administered by the Mayor of Lelu Town Government and shall be
- 10. accounted for in accordance with the Lelu Town Ordinances and applicable rules.
- 11. The Mayor shall be responsible for ensuring the sum appropriated is used solely
- 12. for the purpose for which is apportioned and that no obligations are incurred in
- 13. excess of the appropriation.
- 14. Section 6:Lapse and Date: The sum authorized an appropriated by this Act shall
- 15. be lapsed on September 30th, 2023. Any unobligated amount after the lapse
- 16. shall be transferred back to the Saving Acount of the Lelu Town Government.
