#### BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:

- 1. SECTION 1: PURPOSE: The purpose and intent of this bill is stated
- clearly in its title.
- 3. SECTION 2. APPROPRIATION: The sum of \$860.00 is hereby authorized
- 4. and appropriated from the Lelu Town Treasury to fund all expenses
- 5. related to the Lelu Trading Center.
- 6. SECTION 3. APPORTIONMENT: The sum appropriated in Section 2 of
- 7. this Act shall be apportioned and disbursed as follows:

- 11. SECTION 4. Management: The sum appropriated by this Act shall be
- 12. managed and administered by the Mayor of Lelu and shall be
