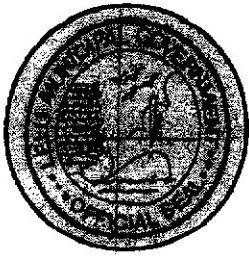

A BILL FOR AN ACT

Relating to the creation and establishment of the Lelu Trading Center and for other purposes.

BE IT ENACTED BY THE 12<sup>TH</sup> LELU TOWN COUNCIL:

1. SECTION 1. Short Title: This Act is known and shall be cited as
2. the Lelu Trading Center Act of 2022.
3. SECTION 2. Statement of Purpose: It is the purpose of the Lelu
4. Town Council to provide for the people of Lelu a trading center
5. to promote the farming and fishing industry and to create for the
6. people alternative income streams through farming, fishing, wood-
7. carving, and other local trading skills.
8. SECTION 3. Establishment: There is hereby established the Lelu
9. Trading Center as a practical vehicle of promoting self-reliance
10. and connecting people towards the attainment of economic
11. development and social integrity. The LTG shall encourage the
12. Lelu Farmers and Fishing Corporative to undertake the actual
13. formation and organization of the Lelu Trading Center and
14. shall create an atmosphere that is conducive to the growth
15. and development of the market.
16. SECTION 4. Creation, Composition, Supervision: There shall be
17. a Board of Directors to be known as the Lelu Farmers and Fishing

18. Corporation (LFFC) consisting of five (5) board members appointed  
19. amongst and by the fourteen (14) members of the Lelu Farmers  
20. Cooperative Association and the Lelu Fishing Cooperative  
21. Association. The Board of Directors shall be consisting of a  
22. Chairman, a Vice Chairman, a Secretary, a Treasurer, and a  
23. Secretary Treasurer. Neither association shall hold no more  
24. than 3 seats in the LFFC Board of Directors.

25. SECTION 5. Functions: The Lelu Farmers and Fishing Corporation  
26. shall function in accordance with the terms and condition set  
27. forth in the Lelu Trading Center Memorandum of Agreement  
28. (MOA), and in harmony with the laws and ordinances of the State  
29. and Local Government altogether.

30. SECTION 6. Holding Over: A member of the Board of Director holds  
31. office beyond his/her term until such time that a successor takes  
32. office.

33. SECTION 7:Vacancy : In the event a vacancy occurs in a membership  
34. of the Board of Directors by the numbers by means of the  
35. following :

36. 1) Submission of a written resignation to the body's  
37. presiding officers and the Mayor.

38. 2) Death

39. 3) Incapacitating illness

40. 4) Absences from three consecutive governing body  
41. meetings.

42. 5) Continuous absence from the municipality or the  
43. state for a period of six months.

44. 6) Removed by the Council for malfeasance in the  
45. office. The process for filling a vacancy is  
46. pursuant to Section 4 of this Act.

47. SECTION 8. Effective Date: This Act shall become law upon the  
48. the signature of the Mayor or upon its becoming law without  
49. such signature.
