A BILL FOR AN ACT

To appropriate the sum of \$4,200.00 (Four Thousand Two Hundred Dollars Only) from the Lelu Town Treasury to supplement the operation cost of the Legislative Body for the period ending September 2022.

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL

- 1 **Section 1: Purpose:** The purpose and intent of this bill is stated clearly in its title.
- 2 **Section 2: Appropriation:** The sum of \$4,200.00 is hereby authorized and appropriated to
- 3 supplement the operation cost of the Legislative Body for FY2022.
- 4 **Section 3: Apportionment:** The sum appropriated in Section 2 of this Act shall be apportioned
- 5 and disbursed as follows:

20 **Section 4: Management.** The sum appropriated by this Act shall be managed and administered
 21 by the Chairman of the 12th Lelu Town Council and shall be accounted for in accordance with
 22 the Lelu Town Ordinances and applicable rules. The Chairman shall be responsible for
 23 ensuring the sum appropriated is used solely for the purpose for which is apportioned and that
 24 no obligations are incurred in excess of the appropriation.

25 **Section 6: Lapse Date:** The sum authorized and appropriated by this Act shall be lapsed on
 26 September 30th, 2022. Any unobligated amount after the lapse date shall be transferred back to
 27 the General Treasury of the Lelu Town Government.

28 **Section 7: Effective Date:** This Act shall become an ordinance upon the approval by the Mayor
 29 or upon its becoming an ordinance without such signature.
