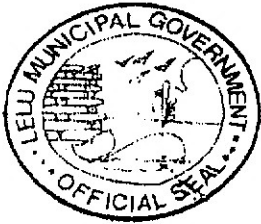

A BILL FOR ACT

To appropriate the sum of \$446.40 from the Lelu Town Government Treasury for the fiscal year ending September 30, 2019 for the purpose of compensating the cost of overtime for the Chief Clerk of the Lelu Town Council for performing work outside of normal working hours during regular and special sessions of the Lelu Town Council and for other purposes.

BE IT ENACTED BY THE TENTH LELU TOWN COUNCIL :

1. SECTION 1. Purpose and Indent : The purpose of this Act is to
2. appropriate the sum of \$446.40 from the Lelu Town Treasury for the fiscal
3. year ending September 30, 2019 for the purpose of funding overtime cost for
4. the chief clerk of the Lelu Town Council for the work perform outside
5. Government normal working hours.
6. SECTION 2. Verification of Hourly Rate and overtime Hourly Rate :
7. following are the regular hourly rate and the overtime hourly rate for the chief
8. clerk of the Lelu Town Council.
9. a. Regular Hourly Rate - \$3.72
10. b. Over Time Hourly - \$5.58
11. SECTION 3. Eligibility : In order to be eligible for overtime, the employee
12. shall worked and completed thirty two (32) hours a week. Any hours worked in
13. excess of thirty two (32) government regular working hours shall be treated and
14. compensated as overtime at the rate of  $\$3.72 \times 1.5 = \$5.58$ .
15. SECTION 4. Apportionment : All funds appropriated in the amount of
16. \$446.40 shall be apportioned as follow using the minimum rate of (2) hours for
17. each meeting if the length of the meeting exists (2) hours.

  9. Unless the length of a meeting reach an hour or less, the compensation for
  10. over time shall be compensated at one (1) overtime hour per meeting at the rate
  11. of \$ 5.58.

12. SECTION 5. Allottee : All fund appropriated in this act shall be
13. managed, controlled administered and accounted for in accordance with
14. applicable laws, included, but not limited to, the Financial Act 2007. The
15. allottee shall be responsible for ensuring that this fund, and so much thereof
16. as may be necessary, are use solely for the purpose specified in this act, and
17. that no obligation is incurred in excess of the sum appropriated. The allottee of
18. the fund appropriated under this act shall be the chairman of the Lelu Town
19. Council. The authority of the allottee to obligate fund appropriated by this act


