**A BILL FOR AN ACT**

To authorize and appropriate the sum of \$ 995.00 from the Lelu Town Treasury for the purpose of funding the Sales Manager servicing under the LFFC ending fiscal year 2022; and further appropriating the sum of \$ 4,308.00 to continue the funding of this service ending fiscal year 2023; and for other purposes

BE IT ENACTED BY THE 12<sup>th</sup> LELU TOWN COUNCIL

1           Section 1. Purpose and Finding. The Lelu Farming and Fishing Corporation  
2           (LFFC) is in its introductory operations which links to LTO 11 - 26. The LFFC  
3           further recognized by way of a Memorandum of Agreement between the Lelu  
4           Town Government and the Lelu Farming and Fishing Cooperative Association.  
5           Since this operation is newly begun, the Twelfth Council finds it is beyond a  
6           necessity and would be the best interest of the Lelu Town Government to  
7           authorize and appropriate the sums reflected in the title and section 2 of this Act  
8           for the purpose of guaranteeing a strong inception of this operation.

9           Section 2. Apportionment. The sum appropriated in this Act shall be  
10          apportioned as follows:

11	(a) Total Base	\$ 845.75
12	(b) Fringe Benefit	\$ 149.25
13	FY 2022 - Total Personnel Budget	\$ 995.00
14	(a) Total Base	\$ 3,661.80

15 (b) Fringe Benefit \$ 646.20  
16 FY 2023 Total Personnel Budget \$ 4,308.00

17 Section 3. Management of Fund. The sum appropriated by this Act shall be  
18 managed, administered, and accounted for in accordance with applicable rules and  
19 ordinances of the Lelu Town Government. The Mayor shall ensure the sum  
20 appropriated in this Act is transferred to LFFC account. Furthermore, the LFFC  
21 Board shall be responsible for ensuring the funds appropriated are used  
22 solely for the purpose specified in this Act, and no obligations are incurred in  
23 excess of the sum appropriated. It shall be a duty of the LFFC Board to  
24 prepare and submit to office of the Mayor a complete and accurate report on  
25 monies expended for the purpose of this Act.

26 Section 4. Lapse Date. The sum of \$ 995.00 appropriated by this Act shall  
27 be lapsed on September 30<sup>th</sup> 2022. The sum of \$ 4,308.00 shall be lapsed on  
28 September 30<sup>th</sup> 2023. All remaining amount of each fiscal year shall be  
29 transferred back to the General fund of the Lelu Town Treasury.

30 Section 5. Effective Date. This Act shall become effective upon  
31 approval by the Mayor or upon its becoming an ordinance without such signature.
