

BE IT ENACTED BY TENTH LELU TOWN COUNCIL :

1. **SECTION 1.** Title : This ordinance shall be known as Lelu Business Ordinance.
2. **SECTION 2.** Definition: For purpose of this ordinance :
3. **(1) Wholesale:** means the purchase of goods for sale to a person who is not the
4. ultimate consumer.
5. **(2) Retail :** means the purchase of goods for sale to a person who is ultimate
6. consumer.
7. **(3) Business :** means a person engage in supplying a product or services to a public for
8. consideration.
9. **(4) Regular Sales :** means operating a business not less than seven calendar days in a
10. month.
11. **(5) Exemption Business :** Any Business operates less than seven calendar days in a
12. month shall require to pay a fee of \$5.00.
13. **SECTION 3.** Business License : All purpose shall acquire a Business License before
14. operating a business within Lelu Municipality or conducting regular sales within Lelu
15. Municipal sites. A separate Business License shall be required for each location sites, or
16. facility and for each Business listed in Section 4. One Business License shall be required
17. for business listed in Section 4 which conducts regular sales within Lelu Municipality.
18. **SECTION 4.** License Fee : All business shall be paid accordingly to the following

9. made payment to Treasury of the Lelu Town Government. Business License shall be
10. paid no later January 31, of each year.

11. **SECTION 6. Penalty :** Any delinquent amount shall be assessed a \$ 10.00 late charge
12. per month.

13. **SECTION 7. Proration :** Any Business started during a year shall have their license fee
14. prorated.

15. **SECTION 8. Effective Date :** This Act shall become law upon its approval by the Mayor or
16. upon its becoming law without such signatures.


