A BILL FOR AN ACT

To amend LTO 06-22, by amending section 1 and 2 thereof, for the purpose of creating an escrow account in preparation of future funding to the Lelu Liberation Day, Lelu Charter Day and Lelu Memorial Day on an annual basis and any other related activities relating to the above activities.

BE IT ENACTED BY THE LELU TOWN COUNCIL :

1. **SECTION 1.** Section 1 of Lelu Town Ordinance 06-22 is hereby amended to
2. read as follows :

3. **SECTION 1.** Purpose and Intend : To establish an account by way of a saving
4. account for the Lelu Town Government to accommodate the necessary financial needs for
5. the purpose of funding the Lelu Liberation activities, Lelu Charter Day activities and the
6. Lelu Memorial Day activities annually. Propose funding shall be submitted to the office of
7. the Treasurer, the Mayor of ITG and the Chairman of the Lelu Town Council for approval.

8. **SECTION 2.** Section 2 of Lelu Town Ordinance 06-22 is hereby amended to read
9. as follows:

10. **SECTION 2. Creation of Escrow Account:** It shall be the responsibility of the
11. Mayor and the Treasurer to ensure that the amount of \$ 1,337.00 shall be extracted from
12. the Local Revenue collected on a monthly basis and shall be deposited to the escrow
13. account. It shall also be the responsibility of the Mayor and the Treasurer of the Lelu Town
14. Government to ensure that the amount shown above shall be made available on the first
15. collection day of each month and shall deposited into a separate checking account or
16. savings account at any banking institution. The amount of \$1,337.00 shall be deposited
17. into the saving account of the Lelu Town Government on a monthly basis. Any an all
18. financial assistance collected during and after each activities shall be deposited into the

2. Deposited according to each activity.
3. a) Lelu Liberation Day \$ 700.00 - $\$700.00 * 12 = \$8,400$
4. b) Lelu Charter Day \$ 425.00 - $\$425.00 * 12 = \$5,100$
5. c) Lelu Memorial Day \$ 212.00 - $\$212.00 * 12 = \$2,544$
6. The total amount shall born an average of \$ 16,044.0 annually. It shall also be the
7. responsibility of the Treasurer to submit each deposits made on a monthly basis to
8. such account to the Mayor of LTG and the Chairman of the Lelu Town Council for
9. reference and record keeping.

10. SECTION 3. Section 3 of Lelu Town Ordinance is hereby amended to read
11. as follows:

12. SECTION 3. Disbursements of funds: No funds shall be withdrawn from this
13. Escrow account except in accordance with Article V Section 4 of the Lelu Town
14. Charter.

15. SECTION 4. Effective Date : This act shall become effective upon the


