





A BILL FOR AN ACT

To appropriate the sum of \$3,500.00 from the General Fund of the Lelu Town Government Treasury for the fiscal year ending September 30, 2019, for the purpose of funding professional contractual services (Legal Counsel) for the office of the Mayor and the Town Council and for other purposes.

BE IT ENACTED BY THE 10<sup>TH</sup> LELU TOWN COUNCIL :

1. **SECTION 1.** The sum of \$3,500.00, or so much thereof as may be necessary, is
2. hereby appropriated from the general fund of the Lelu Town Government for the
3. fiscal year ending September 30, 2019 for the purpose of funding a Professional
4. contractual services (Legal Counsel) for the Lelu Town Government.
5. **SECTION 2.** Apportionment. The \$3,500.00, appropriated under this act, shall
6. be apportioned for the office of the Mayor and the Councils as;
7.       a) Contractual Services                               \$3,500.00
8. **SECTION 3.** Allottee. All fund appropriated in this act shall be control
9. administered and accounted in accordance with the laws. The allottee of this
10. act shall be the Mayor of the Lelu Town Government.
11. **SECTION 4.** Payment Requirement. All fund disbursed in this act shall be
12. accounted and controlled according to the policy, and disbursement shall be
13. made in line with the request and approved by the Mayor with all supporting
14. reporting documents be attached with the payment request.
15. **SECTION 5.** Re-Programming. All fund obligated in this act and that are not
16. used before September 30, 2019 shall not be reprogramming and shall reversed
17. into the general fund of the Lelu Town Government.
18. **SECTION 6.** Effective date. This act shall be in effect upon the approval of the
