**A BILL FOR AN ACT**

To established and designate January 10<sup>th</sup> of each year as a legal holiday for the Lelu Town Government and the people of Lelu Municipality to observe this day as the Lelu Charter Day and for other purposes.

BE IT ENACTED BY THE LELU TOWN COUNCIL OF THE LELU TOWN GOVERNMENT:

1. SECTION 1. Article IX Section 5 of the Lelu Town Charter is hereby authorizing
2. the establishment of a Municipal holiday by way of an ordinance.
3. SECTION 2. MUNICIPAL HOLIDAY :
4. The following day shall be observed as a municipal holiday for the Lelu Municipality :
5.       1. The 10<sup>th</sup> day of January of each year shall be designated as a legal
6.       the people of the municipality of Lelu for the purpose of commemorating the
7.       the effective date of the Lelu Town Charter ;
8.       2. This special day shall be celebrated by the people of Lelu to show our
9.       utmost appreciation to our forefathers and most of all to our all mighty father
10.       for providing such charter to uphold peace and harmony and to guide us
11.       through the establishment of a government that is base on democratic
12.       principles and justice to all within the jurisdiction of the Lelu Municipality ;
13. SECTION 3. There shall be activities held on this day to celebrate the purpose behind
14. the Lelu Charter Day. Following events shall be presented on this very special holiday
15. depending upon availability of funding.
16.       1. A Lelu Charter Day planning committee shall be formed by the office of
17.       the Mayor to coordinate the activities on this day without compensation.
18.       2. An educational program shall be held on this day for the people of Lelu
19.       to understand the meaning behind this holiday.

20. 3. The Mayor of Lelu Town shall be the keynote speaker on this special day  
21. to address the public on the history of the Lelu Town Charter. If the Mayor is

24. public on his behalf.

25. 4. Sporting activities shall be part of this holiday celebration.

26. SECTION 4. This act shall become law upon the approval of the Mayor of Lelu Town  
27. Government or upon its becoming law without signature.
